To the Board of Governors, Port Jefferson Yacht Club.

I hereby apply for Introductory Membership.

The names and ages of the members of my household are as follows:

I (We) do _____, do not _____ own a boat. I (We) will _____, will not _____ be storing a boat on PJYC premises.

The description of the canoe, kayak, paddleboard or other similar craft (if any) that will be stored on SYC premises is:

Storage of said craft is limited to assigned rack in the PJYC lower parking lot and to between April 15 and October 15 of the membership year. The PJYC east dock may be used for launching, boarding and/or landing. Use of the west (main) dock for boarding and/or landing is not permitted. Arrangements for rack space must be made pursuant to Club procedures. The annual fee for rack space is waived for one boat.

Introductory Membership

A Non-Voting, Non-Launch Introductory Membership would be open to persons who do not own a boat or whose boat ownership is limited to the type of boat, i.e. canoes, kayaks, stand up paddle boards or at the discretion of the Board of Directors, capable of being placed on an existing rack for storage. The Board of Directors shall set the annual dues for the Introductory Membership at the annual meeting and the established rack rental fee will be assessed for each boat to be stored. In addition to the use of the rack, the membership shall include parking and Clubhouse access. This membership shall not require an initiation fee; dues are payable annually. An Introductory Membership shall have a maximum term of two years and the member shall not be eligible to hold office nor chair any committee. At the discretion of the Board, all assessments (including the Work assessment), except those specifically applied to the boat storage rack, shall be waived for this Introductory membership category. Application for such memberships shall be made to the Board of Directors through the membership committee. Introductory Members who wish to remain members of the Port Jefferson Yacht Club after the expiration of two years will be required to pay the initiation fee and apply for regular membership. If at any time during the term of the membership, the Introductory Member wishes to convert to a Non-Launch or Launch member, the member may apply for regular membership in the

club. Upon acceptance, the initiation fee is to be paid along with the difference between the Introductory Activity Membership dues and regular membership dues. The Introductory Member will receive a credit toward the initiation fee of \$250.00 for each year of Introductory Membership.

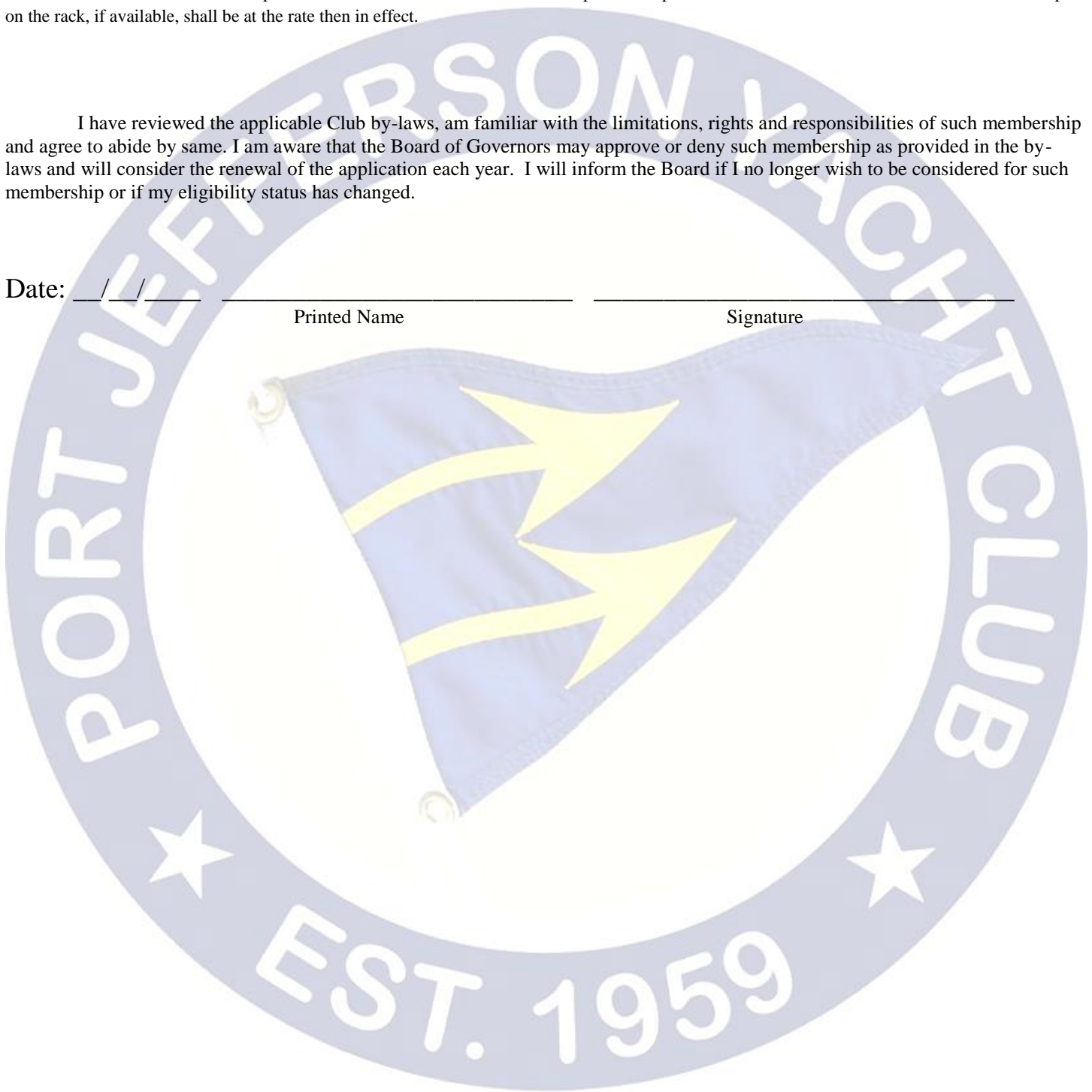
The annual dues for this membership shall be \$750.00. Annual dues will not be prorated. Space on the rack for one boat is included. Additional space on the rack, if available, shall be at the rate then in effect.

I have reviewed the applicable Club by-laws, am familiar with the limitations, rights and responsibilities of such membership and agree to abide by same. I am aware that the Board of Governors may approve or deny such membership as provided in the by-laws and will consider the renewal of the application each year. I will inform the Board if I no longer wish to be considered for such membership or if my eligibility status has changed.
