Alan Johnson and his team successfully removed the docks in November. It was a perfect day and Alan has prepared his to-do list to get the docks ready for launching in April. Alan updated the prices on Dockwa for our 2020 season and Ed Dowd, our immediate Past Commodore and this year's Director of Launches has updated the launch schedule on our website. In 2019 Alan managed our online reservation system, Dockwa, to maximize the number of paying transients on our docks. We have been looking for a member, who needs to complete work hours, to take this task over. You do not have to be present at the club to manage this service, Alan handled the operation from home, from his boat, and from the club. A smart phone or computer is what is needed and Alan will provide the training. Please reach out to him if interest-ed.

Members have been asking for a coat rack in the club. Our Director of House, Kevin Mularkey has obtained a coat rack and we will see how it works. We also created a Beautification Committee at the Annual Meeting to explore updates to the Club and grounds. Please reach out to Kevin if interested in serving on this Committee. Things to be decided are colors for the walls, improvements to the interior and exterior of the Club as well as the grounds. We have had several members express interest.

Mitch Slochower has joined the Board as our Director of Grounds. He will be coordinating a Spring cleanup with the members as well as the Crew and Sailing Teams of SBU. Many members need hours and this is a great way to get them done before the boating season begins. We want the Club in pristine condition when we have our Commissioning. If you have any old equipment or boats stored at the Club please remove them now. If you have boats on the racks and cannot remove them we do have a storage fee for winter storage so you will receive an invoice. During the Spring clean-up we will remove anything that does not have an owner.

Jeff Hausner, our Vice Commodore has prepared a plan for cameras to record activity around the Club house and the upper and lower lots. We are looking into fiber optic service at the lower lot that will allow for camera coverage of our docks as well.

We are exploring the possibility of a new membership category that will allow members to share ownership of a sailboat and/or powerboat. We are currently working on the details of this and a proposal will be complete by our next board meeting. Tim Rachek, our Rear Commodore has taken on this project along with improving the Junior Sail Program along with David Diamond. Alan Siris has also volunteered his time to help craft an emergency response program with our Junior Sail Program.

Rich Spitzenberger, CPA joined the Board as our Treasurer. He has been working with Tim Rachek to make a smooth transition. Please contact Rich with any reimbursement requests or if you have question regarding dues, due dates, etc. Welcome Rich!

We just had our first board meeting with our new commodore Karl Jansen and several new board members and it looks like we are off to a good start. Docks and Floats

PJYC had a very good 2019 with the docks. We had record income and very few repairs in 2019. Looking forward, we will be relocating some cleats and fastening them more securely to our docks. The electric service will need an upgrade as we had an issue with the conduit under the West dock last season. We intend to replace that conduit with a much larger conduit without any splices and upgrade the wire that is installed.

Some members missed the annual meeting and at that meeting I made a short presentation about expanding our dock space to accommodate more boats for both transients and members. The yacht club has begun the process to add nine finger piers to the west dock. Ihe theory, is that with both docks we will be able to accommodate 20 boats in slips or alongside and have about 115 linear feet of space to tie up alongside. We presently have 480 linear feet of space to tie up alongside . When the proposed layout is finished we will have about 955 linear feet of tie up dock space able to accommodate 20 boats in slips and 115 linear feet of space for tying up alongside. We believe we can triple our dock income and provide a 100% increase in dock space available for member s to tie up. The paper work for the finger piers on the West dock has been started in anticipation of a signed lease. Every dollar in transient income offsets dues increases.

We continue to have dinghies, canoes and motors stored on the dingy dock that will prevent working on the JSP floats unless they are removed. At some point the board will have to consider them abandoned and remove them from our property.

I have seen the list of members who were not able to fulfill their work assessment hours . Volunteering to be the Dockwa contact at the club would fulfill your obligation. It can be done on a smart phone, tablet or computer, or any combination of equipment, and from anywhere you have cell service or wi-fi. The job requires that you manually confirm reservations after the system automatically confirms reservation requests for about 2/3 of the available moorings and 50% of our rentable dock space and answer any question the transients may have. When we start to fill up, we want to be sure we do not overbook.

Our docks will be going in on April 4 of this year. Work parties will be announced starting in early March. It should be an easy prep for launch and not a lot of hours will be needed so plan your work assessment hours accordingly. We will be using as much help as is available on April 4 as the more labor we have, the faster we are done.

PUMP OUT STATION

I am not sure that everyone has been made aware that the Town of Brookhaven has installed a new pump out station on the Harbor Masters dock. It is fully automated and available 24/7. It is located at the end of the dock that PJ Launch used to drop off transients in the village.

After years of sailing pleasure, we have surrendered to our age and will sell our beloved 1987 Pearson 36-2. She is a comfortable cruiser (and occasional racer) and is offered in sail-away condition. The 36-2 has an overall Length of 36'6", the designed waterline length is 29' 7", and beam is 12'4". The underbody configuration is a keel-centerboard, drawing 4 2" with the board up and 8'3" with the board down.

Partial List of Additions and Modifications

- The ice box has been upgraded with Adler-Barber refrigeration
- The boat was re-engined in 2002 with a Yanmar 3GM30F and the prop has been upgraded to a 2-blade, feathering, Max-Prop. It has wheel steering and an Autohelm auto pilot
- The standard 55amp alternator has been replaced by a Balmar dual output 100amp alternator and "smart" regulator
- A third battery, dedicated to the engine, was added with all three house, refrigeration, and engine batteries automatically charged anytime the engine is running.
- The main cabin table was replaced with a custom design that seats 6 and allows walk-in access to the starboard storage area.
- The 153% genoa is mounted on a Harken furler and the main has been converted to a Doyle Stackpak.
- A dodger and bimini is installed, with a centerpiece and side curtains that can be zipped on to enclose the entire cockpit, or removed to suit the weather conditions.
- Radar and GPS were added to the instrumentation suite and the radio was upgraded to a DSC compatible unit. The GPS provides data to a remote display, the radar display, and the DSC radio.

Minutes of November 4, 2019 Board Meeting

Meeting Called to Order: 7:15 PM by Commodore, Ed Dowd

Present: Ed Dowd, Karl Janhsen, Ellie Bowman, Tim Rachek, Kay Rachek, Alan Johnson, Kevin Mularkey, Karen Janhsen, Laurina Nielsen, Joe Yorizzo, Keith Puls, Jeff Hausner, John Ciarelli, Dave Hubbard, David Diamond

Recording Secretary: Ellie Bowman – The October 7, 2019 minutes were reviewed and approved by the Board. Discussion regarding outstanding work hours. The Recording Secretary's Report was approved by the Board.

Commodore: Ed Dowd– We will keep a launch in the water until the docks come out. The Commodore's report was approved by the Board.

Vice Commodore: Karl Janhsen – Working on the budget. Met with SBU crew team and signed contract for June to June. SBU sailing team contract is from May to May. Both teams will pay dues by November 30, 2019. The Vice Commodore's report was approved by the Board.

Rear Commodore: Jeff Hausner – Working on pricing for a fiber optic cable to run from the clubhouse to the sailing school building for cameras and communication. The Rear Commodore's report was approved by the Board.

Corresponding Secretary: Kay Rachek – Currently there are 93 members. There are 62 Launch Members, 11 Non-Launch Members, 3 Emeritus Members, 9 Small Vessel Members 2 SBU Team Members and 6 Honorary Members. The Corresponding Secretary's Report was approved by the Board.

Treasurer: Tim Rachek – As October 31st our cash balances are \$105,317 of which \$67,000 are reserves. The cash balances are running ahead of this time last year. Remaining expenditures for the year are sales tax of around \$12,000, launch payroll, launch repairs and dock removal. The SBU dues should be in before the end of the year. Expect to finish the year with a surplus. We should raise dues 2% next year. The final accounting of soda machine is that we lost a couple of hundred dollars. The Treasurer's Report was approved by the Board.

Judge Advocate: John Ciarelli – Nothing has changed with the lease negotiations. Still waiting for the appraisal to be changed regarding initially charging us for more usable property than we have. The Judge Advocate's Report was approved by the Board.

Social: Karen Janhsen – Italian Bistro night was very successful. The Jeopardy and barbeque party went very well. The Annual Dinner Dance will be November 9th. Chic Voorhis will be supplying the music. Leighann Kelly will be organizing the Christmas Party December 13th. The Social Director's Report was approved by the Board.

Fleet Captain: Dave Hubbard – We will be keeping Jerimiah. Undecided about Pintail. The Fleet Captain's Report was approved by the Board.

Launch & Moorings: Joe Yorizzo – We need to get an AED. Setauket's tank needs to be cleaned. Will be pulling out last launch this week. The Launch and Moorings Director's Report was approved by the Board.

Docks and Floats: Alan Johnson – Revised revenue for 2019 is \$22,211, which is 32% ahead of last year. Revenue for three years is \$47,849. Dockwa recorded 142 dock reservations for 2019 and 31 of those reservations were for more than one night. After adding the finger piers, we will have a 250% increase in our rentable transient space and still have 8 slips and 100+ feet of along-side tie up space. We presently have 520 l.f. of dock space. After installation of the finger piers we will have 940 l.f. of dock space. We continue to look for a volunteer to supervise Dockwa. Docks are scheduled to come out November 9th. Members have been notified about dinghies, motors, paddle boards, etc. that must be removed. Field survey work for the finger piers application was completed today. Next year instructions for leaving your boat on the overnight will be added to the dock rules. The docks will need minor work to get them back in the water next year. Pricing for the docks should remain the same as this year's rates except we should raise the rates for July 4th and Labor Day weekends by \$.50/ft. After we sign the new lease we will get the survey for the underwater and waterfront. The Docks and Floats Director's report was approved by the Board.

Education: David Diamond – Wrapping up the season. Still looking for a chase boat. The Education Director's report was approved by the Board.

House Report: Kevin Mularkey – Downstairs is just about finished. Still needs painting. Discussion regarding the bathrooms. Deck furniture was moved downstairs. The House Director's report was approved by the Board.

Grounds: Keith Puls – Keith Puls made a motion 2^{nd} by Alan Johnston to hire a landscaping company for the property and was unanimously approved by the Board. The Grounds Director's report was approved by the Board.

Past Commodore: Laurina Nielsen. Need to fix the light fixture at the top of the stairs. Asked if the launch drivers took the sexual harassment course. The Past Commodore's report was approved by the Board.

New Business:

The Port Jefferson Rowing Club wants to store their boats here for the winter.

At the Coast Guard Meeting on Thursday January 9th we will give them a key to the club so that a member does not have to continue to let them in.

Adjourned: Motion was made to adjourn the meeting at 9:10 p.m. by Alan Johnson, 2nd by Joe Yorizzo and approved by the Board.
