I ACKNOWLEDGE THAT I HAVE SOLE RESPONSIBILITY FOR THE SAFETY OF MY CREW AND YACHT. SETAUKET YACHT CLUB INC. RACE COMMITTEE AND THE SPONSORS OF THE TNIR ARE IN NO WAY TO BE HELD RESPONSIBLE FOR ACCIDENTS, DAMAGE TO PROPERTY OR TO YACHTS, OR INJURY TO CREW OR GUESTS ARISING FROM ANY CAUSE DURING, OR RELATED TO, RACE OR ACTIVITIES OF THE TNIR. WEATHER AND SEA CONDITIONS MUST BE EVALUATED BY EACH SKIPPER AND HIS CREW AND EACH PARTICIPANT IS RESPONSIBLE FOR DETERMINING IF IT IS SAFE FOR HIM TO PARTICIPATE. THE RESPONSIBILITY OF WEARING A LIFE JACKET RESTS UPON THE SKIPPER AND HIS CREW. IF ASSISTANCE IS PROVIDED BY COMMITTEE VESSELS AND PERSONNEL, IT IS AT THE RISK OF THE PARTICIPANTS. I HEREBY AGREE TO ALL OF THE CONDITIONS FOR THE TNIR AND SHALL INFORM EACH MEMBER OF MY CREW TO THESE CONDITIONS. I HEREBY WARRANT THAT MY YACHT WILL BE OUTFITTED, EQUIPPED AND HANDLED IN ACCORDANCE WITH THE CONDITIONS FOR RACING; THAT SHE WILL HAVE ALL THE REQUIRED EQUIPMENT ON BOARD; THAT SHE IS SEAWORTHY IN HULL, RIG, AND GEAR; AND THAT SHE WILL BE COMPETENTLY MANNED. IN CONSIDERATION WITH YOU ACCEPTING MY ENTRY FOR THE TNIR I DO FOR MYSELF, MY EXECUTORS, MY ADMINISTRATORS, AND ASSIGNS WAIVE AND RELEASE ANY AND ALL CLAIMS THAT I MAY HAVE AGAINST SETAUKET YACHT CLUB INC., THE RACE COMMITTEE, THEIR OFFICERS, DIRECTORS, MEMBERS, COMMITTEE MEMBERS, VOLUNTEERS, EMPLOYEES, AND AGENTS OR ANY ONE OR MORE OF THEM OR THEIR EXECUTORS, ADMINISTRATORS, HEIRS, NEXT OF KIN, SUCCESSORS, OR ASSIGNS, INCLUDING ANY AND ALL CLAIMS FOR DAMAGE CAUSED BY THE NEGLIGENCE OF ANY OF THEM ARISING OUT OF MY PARTICIPATION OR THAT OF MY YACHT IN THE TNIR AND ITS RELATED ACTIVITIES INCLUDING PRE-START AND POST FINISH OPERATIONS AND SHORE ACTIVITIES TOGETHER WITH ANY COST AND EXPENSES INCLUDING ATTORNEY'S FEES THAT MAY BE INCURRED AS A RESULT OF ANY SUCH CLAIM WHETHER VALID OR NOT. I DO HEREBY AGREE TO INDEMNIFY AND HOLD HARMLESS EACH OF THEM AGAINST ANY SUCH CLAIMS THAT ANY OFFICER, MEMBER, OR CREW OR ANY OF MY GUESTS (OR THE EXECUTORS, ADMINISTRATORS, HEIRS, NEXT OF KIN, SUCCESSORS, AND ASSIGNS OF ANY OF THEM) MAY HAVE OR ASSERT TOGETHER WITH ANY COSTS AND EXPENSES INCLUDING ATTORNEY'S FEES WITH RESPECT THERETO.
